Crystal Creek Park Rules

You enter the farm at your own risk and all visitors will be required to confirm they will abide by these Park Rules and complete a waiver prior to entry



General

- This is a "no glass" Park
- Children under 16 years are to be supervised by adults
- No pets allowed
- Generators and loud music are not permitted after 7pm
- All persons are required to obey signs and directions and leave gates as found (close if unsure and call Park management 0417 952 006)
- Any areas designated <u>No Entry</u> must be abided by at all times
- No firearms, crossbows or fireworks permitted
- No Trespassing on neighbour's property. Trespassers will be prosecuted
- All visitors are responsible for their own rubbish and are required to take it with them on exiting the Park (a rubbish bag will be provided at check-in)
- Please use the toilets provided. Chemical toilets <u>are not</u> to be emptied anywhere on the Park, especially our toilets and anyone caught disposing of their chemicals will be reported to the authorities and required to repair any damage to our systems
- Campfires are permitted when staying at the Park, existing firepits only must be used and fires must be
 fully extinguished when finished. Note: NSW fire restrictions apply. Please check with Park management
 on your day of arrival
- All instructions from Park management are to be complied with immediately

Driving

- Keep speed to a maximum of 25 km/hr in the Park and 5km/hr in the campgrounds
- NSW Road rules apply
- No alcohol to be consumed whilst driving
- No driving under the influence of drugs or alcohol
- All passengers must have a seat. No riding on trays of vehicles.
- Seatbelts or other restraints are to be worn whilst the vehicle is in motion.
- Vehicles are not to be driven on the 4WD tracks between 6pm and 8am, this curfew is strictly enforced
- Follow only marked 4WD tracks
- No donuts are to be performed in the Park
- No engine revving whilst the vehicle remains in the campground
- No motorbikes or unregistered vehicles are permitted at the Park
- No trees are to be cut down and no dragging of logs behind vehicles for firewood
- If your vehicle is inadvertently stranded, a recovery fee applies <u>if</u> a recovery vehicle is available. Recovery fees are payable in advance:
 - o \$150.00 per hour easy to hard tracks (1 hr min)
 - \$200.00 per hour extreme tracks (1 hr min)

We are a family friendly park and have these rules so everyone can enjoy their time in a safe manner, so please be considerate of others. A breach of any of the above rules will result in exclusion from the Park at the discretion of Park management. Should this occur, the visitor shall forfeit any monies paid.

Please Report to Us

- If vehicles are speeding through the Park or campground or causing environmental damage
